## **EQUESTRIAN BAHAMAS RELEASE, ASSUMPTION OF RISK, WAIVER AND INDEMNIFICATION**

### **THIS DOCUMENT WAIVES IMPORTANT LEGAL RIGHTS. READ IT CAREFULLY BEFORE SIGNING**

THE CLUB AGREES in consideration for participation in any and all Equestrian Bahamas- licensed and/or endorsed competitions (each a "Competition") to the following:

THE CLUB AGREES that Equestrian Bahamas ("EB") and "Competition" as used herein includes the Licensee and Competition Management, as well as all of their officials, officers, directors, employees, agents, personnel, volunteers and any and all EB affiliates associated with such Competition.

THE CLUB AGREES TO participate voluntarily in any Competition with horses owned by the Club, being fully aware and acknowledging that horse sports and any Competition involve inherent dangerous risks of accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering, or death ("Harm").

THE CLUB AGREES to hold harmless and release EB and any Competition from all claims for money damages or otherwise for any Harm to Club members or Club-owned horses and for any Harm of any nature caused by Club-owned horses to others, even if the Harm arises or results, directly or indirectly, from the negligence of EB or any Competition.

THE CLUB AGREES to expressly assume all risks of Harm to Club-owned horses, including Harm resulting from the negligence of EB or any Competition.

THE CLUB AGREES to indemnify (that is, to pay any losses, damages, or costs incurred by) EB and any Competition and to hold them harmless with respect to claims for Harm to Club-owned horses, and for claims made by others for any Harm caused by Club-owned horses while at the Competition.

BY SIGNING IN SECTION 4 ON PAGE ONE of the Membership Application, THE CLUB AGREES to be bound by all applicable EB Rules and all terms and provisions of this EB Release, Assumption of Risk, Waiver and Indemnification.
